### **for September 24, 2022 CLA WSO General Meeting**

- **The Treasurer** presented the Financial Activity Statement(s) and reported that we are doing well and staying on budget.
- **The Public Information Committee** presented a new video for CLA's YouTube Channel. The video was entitled CLA Tool #12: Trust. A Motion was voted to approve the video. The motion passed.
